

2022 GREAT GIFT GIVEAWAY WEEK FOUR OFFICIAL RULES

NO ACCOUNT OR PURCHASE NECESSARY TO ENTER OR WIN

1. **DESCRIPTION OF CONTEST:** The Sharon & Crescent United Credit Union 2022 Great Gift Giveaway Week Four is designed to give entrants ("Entrants") the opportunity to win a prize at random.

Send a 3"x 5" index card with your first and last name, date of birth, complete mailing address, and phone # to Sharon & Crescent United Credit Union, ATTN: Marketing Dept., 1300 Belmont Street, Brockton, MA. 02301. On the index card indicate the giveaway name and include your answer to the post statement/question. Any incomplete entry received will not be entered into the Giveaway. A person may only mail one entry throughout promotion period.
4. **WINNER SELECTION:** A random drawing will be conducted on or about December 26, 2022, from among all eligible entries received. Random drawing will be conducted by a representative of Sharon & Crescent United Credit Union, whose decisions are final. Odds of winning will depend upon the number of eligible entries received. Winners will be contacted with a reply to their comment on the special post advertising the promotion, and their name and/or photo may be posted on <https://www.facebook.com/SCUcreditunion> Prize may be awarded to an alternate if potential winner is deemed ineligible or does not follow the instructions within the reply from the Sharon & Crescent United Credit Union Facebook page within 24 hours after the date sent, if time permits. If a winner entered by the alternate method of entry, that winner will be notified by email using the email address provided.
5. **PRIZE:** Six (6) winners will receive a Nintendo Switch console, a Nintendo Switch Pro Controller, a set of Joy-Con Wireless Controllers, and a copy of Mario Kart 8 Deluxe. The prize must be picked up in person by the Entrant, at one of our Sharon & Crescent United Credit Union branch locations. The prize will not be mailed and must be picked up in person. Failure to do so will result in disqualification and the selection of an alternate winner.
